GETTING TO KNOW YOU

This month's feature is two of the park's many Ohioans, Chuck and Sue Loolen, who live near the shores of Lake Erie in Port Clinton during the off season. They were high school sweethearts in Norwalk, Ohio

from their sophomore year to the present, having been married now 54 years. After high school Chuck was drafted into the Marines and began his training in California. Sue drove out to California not long after where they were married. At 19 years old Chuck was sent to Vietnam in service to his country in February of 1968. On an early August morning that year, north of Danang, Chuck's platoon of 12 was ambushed and fired upon; 9 of the men were killed and Chuck's arm was badly wounded. After 24 hours of heavy gunfire he was finally medevacked out with gunfire possibly hitting the chopper yet arrived safely in South Vietnam. Once stable, Chuck was flown to Japan for 3 months of treatment and recovery and then to Bethesda Hospital. His bravery aptly earned him a Purple Heart. When asked, Chuck never suffered any PTSD or night terrors from his 9 months in service. Sue attributed his sense of humor as his coping skill in getting him through and certainly having a bride waiting for him helped!

The Loolens went on to raise 3 children in Ohio. They have 8 grandchildren with another on the way this winter. Chuck's employment career was at Tenneco and Sue worked in a factory and various offices.

Chuck and Sue heard about VPE through friends from their kids' school, VPE owners Sue & Jerry Schwan, Initially, they were renters and enjoyed working at Myakka State Park and other local stores while wintering here. In 2007, they bought their home at 2136 Palazza which was owned by the Smiths, relatives of Phyllis Buechner. One of their happiest memories was seeing their new coach arrive and have so enjoyed the space and amenities in their updated home. They encourage

RECIPE OF THE MONTH

Even though most of us are in Florida now, some days are cooler and call for comfort food. This chicken pot pie will warm us up on those cold winter nights. It has a lot of ingredients but most of them you already have. It is quick and easy and so yummy.

Chicken Potpie with Crescent Roll Topping

- 3 T. butter
- 1 medium onion, chopped
- 2 stalks celery, chopped
- 2 carrots, chopped
- ½ C. frozen peas
- 3 garlic cloves, minced
- 2 C. shredded cooked chicken (I use rotisserie chicken)
- ¼ C. flour
- 1 ½ C. chicken broth



½ t. dried thyme

2 t. dried parsley

1 t. salt

½ t. poultry seasoning

½ t. garlic powder

½ t. pepper

3/4 C. heavy cream or half and half

18 oz. tube of crescent rolls

Melt the butter in skillet and cook the onion, celery and carrots until tender, about 5 minutes. Add the peas in about the last minute. Add the garlic and cook for about a minute. Add the chicken. Now sprinkle the flour into the skillet and stir. Cook for 2 more minutes and then add the chicken broth. Cook for another 2-3 minutes until it starts to thicken but stir constantly. Add the thyme, parsley, salt, poultry seasoning, garlic powder and pepper. Stir in the cream and cook another couple minutes until thickened.

Pour into a sprayed deep-dish pie plate. Spread the crescent rolls over the filling. I put the wider end of each roll at the pie plate edge and the tip at the center. Bake at 375 degrees for about 15 minutes or until the crescent rolls are golden.

A sign-up sheet is posted on the


bulletin board, Please sign up by Thursday, January 6 for a team. Teams vary from 2 to 8.

A BRIEF HISTORY OF VENETIAN PARK ESTATES(CONTINUED):

Founded in 1970, converted to resident owned June 15,1988*

After 14 years the property was offered for sale for \$2,200,000.00. At this time, only 20% of the residents were willing to purchase the property, so the Cutlers and Bigelows sold the property to a group of Michigan investors. When the rent was subsequently raised to \$149.00 per month a group of 12 residents of the park formed a committee to pursue incorporation under the new laws established by the state of FL.

This committee retained the services of Attorney William Korp. (Later, Attorney Harlan Domber became the park's legal representative). Venetian Park Estates, a non-profit organization was registered with the state of FL on June 5,1984. This action gave the residents "limited right of first refusal" should the park again be offered for sale.

The committee also served as a liason with management and consulted with the Federation of Mobile Home Owners and officers of other resident owned parks.

The twelve members of the committee became the first officers of the new organization and contributed towards the required attorney and registration fees.
