### **Cheesy Hawaiian Garlic Rolls**

- 1 T. fresh parsley
- 2 cloves minced garlic
- 1 T. grated Parmesan cheese
- 1 to 2 cups shredded mozzarella cheese

Put the Hawaiian rolls into your baking dish. My dish holds 10 rolls. Make two slits in each roll making sure you do not cut all the way through. Into a bowl add the butter, parsley, garlic and Parmesan cheese. Mix thoroughly. Now stuff the mozzarella cheese into each crevice of the rolls. Then brush the garlic butter mixture generously over the rolls. Bake at 400 degrees for 12 minutes.

## **FROM THE OFFICE**



If you carelessly park on the street or block a neighbor's driveway, it's not just an inconvenience for the owner who needs to use their driveway for parking or existing their property, but it can also prevent emergency vehicles, such as fire trucks, ambulances, and police cars, from accessing a property quickly in the event of an emergency.

R&R 7.9: Unit Parking. Guests are permitted to park in front of a Member's Unit only from 6 am to 12 am. Overnight parking on the street is prohibited by anyone. Guests may use the Clubhouse parking stalls only after the Unit Member's carport is filled. R&R 7.13: Parking at a Neighbor's Carport. Before parking a Motorized Vehicle in a neighbor's carport, permission must be obtained from the Member in writing with a copy filed with the Park office. This permission may be submitted to the office by written letter or by email.
