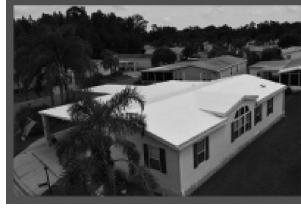

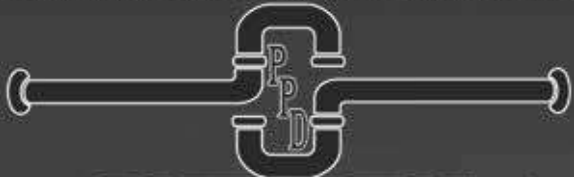

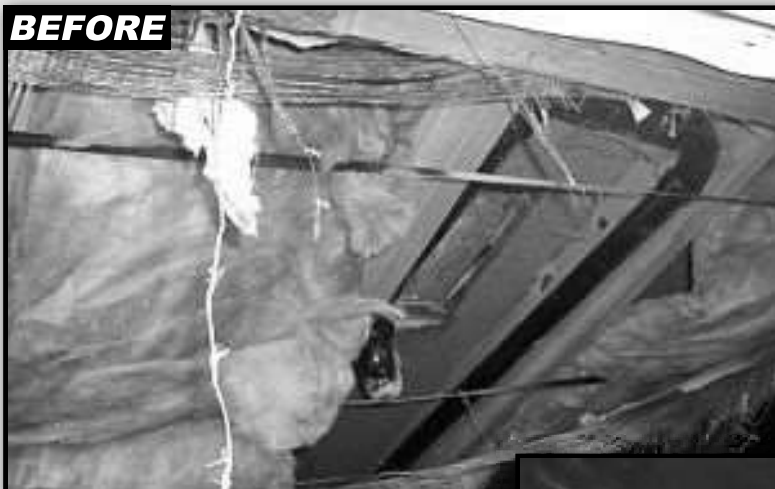

RECIPE OF THE MONTH

Once again I have one of my mom's recipes that was a favorite. She served it many times with her fried rice. It does take a little time to prepare but the last forty minutes or so it just simmers on the stove

so you can finish preparing the rest of the meal.

1/4 C. flour

1/2 t. salt

Pepper

2/3 can evaporated milk

1 small can green chilies, mostly drained

1 1/2 t. chili powder

3 lbs chicken pieces, (Mom used thighs and breasts, I use chicken tenders)

2 T. butter

1 can cream of mushroom soup

1 lb fresh mushrooms, sliced

Combine flour, salt and pepper, add 1/2 t. chili powder. Coat chicken with flour mixture. Melt butter. Fry chicken on 1 side until browned. Turn chicken. Add mushrooms and cook until chicken is browned. Combine soup, evaporated milk, green chilies and remaining 1 t. chili powder. Spoon over chicken. Cover and reduce heat. Simmer 40 minutes or until chicken is tender.

WHEN DOES OUR POOL CLOSE?

Chapter 64E-9.006(2)(c) of the Florida Administrative Code says that pools cannot be open at night (defined as 30 minutes before sunset to 30 minutes after sunrise), unless the pool and pool deck have proper lighting for the safety of patrons, which we do not have.



In our Rules & Regulations, 4.6 states: "The pool and spa are available for use from 8:30 a.m. until sunset." Our pool officially closes at 8:00 PM.

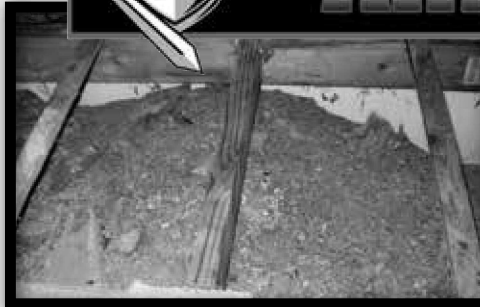

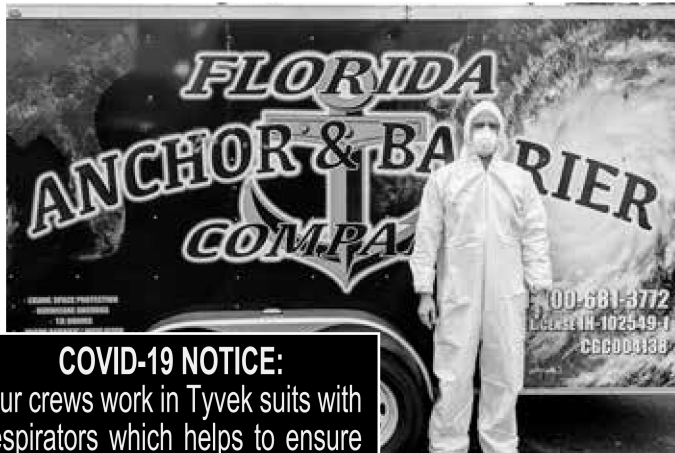
